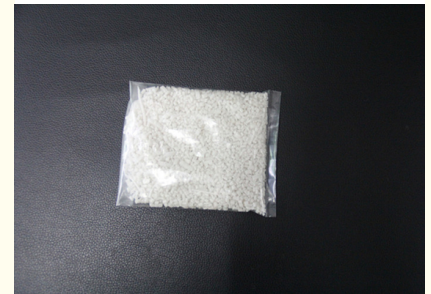

1. Good water-solubility at normal temperature(20±5°C) , no residue like feathering or glue left.
2. Better carrying capacity than usual PE bag.

4. Avoid the use of regular plastic bags (non-water-soluble packaging) which generate large amount of chemical residues.
5. Keep human from direct contact with packed material.
6. Reduce the chemical pollution caused by pesticide / chemical/detergent residues left in the regular plastic bags and avoid contamination to soil and water.
7. The fixed weight of bags increases the dosage accuracy and avoids the wastage in packaging.
8. Keep the seeds from being flown away in strong wind region or eaten by animals.
9. Using PVA bag for fishing could avoid the interference by the fishes in shallow-water area and the bag will dissolve in deepwater area.
10. Bag size and shape can be customized.
